#### **PURPOSE**

- \*To elect National Officers
- \*To amend the National Constitution and Bylaws if necessary
- \*To transact such business as necessary
- \*To meet and enjoy one another's company

#### REPRESENTATION

The Bivouac shall be composed of delegates from all Echelons. Each Echelon shall be entitled to five (5) delegates and five alternates, plus one additional delegate and alternate for each fifty (50) paid members. Paid membership shall be determined **forty (40) days prior** to the first day of Bivouac. All Echelons who are in good standing by <u>August 7, 2022</u>, will be entitled to representation at the Bivouac. Members of the National Cadre from each Echelon shall be delegates to the National Bivouac with the right of the vote. This vote shall be exercised with their respective Echelons.

Echelons (all) 5 delegates and 5 alternates

26 thru 75 members 1 additional delegate and alternate 76 thru 125 members 2 additional delegates and alternates

#### **DELEGATES**

Only paid-up members for the year 2022 are entitled to be a member of the Cadre, a Delegate or Alternate Delegate to the Bivouac. A member is considered to be paid up when \$13.00 per capita for the current year has been received by the National Aide 40 days (<u>July 15, 2022</u>) prior to the National Bivouac. No per capita will be accepted for Bivouac count after that date nor will any Jeepette be listed on the Bivouac registry or receive a Bivouac badge.

#### **CREDENTIALS**

Blank forms will be furnished to all Echelon Aides. The credentials form (Delegate/Alternate Registration Form) must be returned to the National Aide by <u>August 7, 2022</u>. Accompanying the Credential form shall be a check in payment as per this schedule: \$10.00 for the Echelon and \$5.00 for each Jeepette listed on the form. If a Jeepette is deemed to be filling more than one position, do not list her twice. She is to be listed ONLY IN THE HIGHEST POSITION. That is: Past National Director, Current National Officer, National Cadre Member, Echelon Delegate and finally, Alternate Delegate. ALL positions require \$5.00 for each Jeepette listed.

Delegate/Alternate Delegate badges will be issued at the Bivouac for all Jeepettes registered. In extenuating circumstances, registration corrections may be made through the National Aide and Echelon Officers must be presented. The Echelon must have been registered and fees paid PRIOR to to arrival at Bivouac.

#### **HOTEL ROOMS:**


May our Heavenly Father console them in their present sorrow and may these words of appreciation and high regard be a solace in the years to come.

# Military women say DoD reproductive health care far from 'seamless' in post-Roe era

"The department is examining this decision closely and evaluating our policies to ensure we continue to provide seamless access to reproductive health care as permitted by federal law," Defense Secretary Lloyd Austin said June 22.

In 1976, three years after Roe v. Wade legalized abortion up to fetal viability, the Hyde Amendment banned the use of federal funds for most abortions in the United States.

For years, the only abortions the military would facilitate were those for pregnancies that posed a threat to the mother's life. Rape and incest exceptions were added in 2013. Severe and fatal abnormalities of the fetus were never covered. For Wald and her Marine husband, that led to a nightmarish experience in Japan.

After amniocentesis tests came back positive for severe fetal abnormalities, Wald was handed a pamphlet for a Japanese hospital. When they got there, they were told the procedure would take place overnight and cost \$5,000 cash up front. The doctor examined her roughly, she said, using a glove from his pocket that reeked of cigarettes. As the procedure began, the pain was unbearable, and she started bleeding profusely. She called her best friend, an ICU nurse in Arizona, to describe what was happening. The friend conferred with an obstetrician then told her, "You need to leave that place. It's not safe." At home early the following morning, Wald awoke weak with a 105-degree temperature. The Navy hospital emergency room diagnosed her with a lacerated cervix and blood poisoning and started her on intravenous antibiotics, she said. Later that day, doctors decided to induce labor. Her newborn son weighed less than 13 ounces, she said. "I ended up having a compassionate birth after being in a situation nobody wants to be in," she said, lauding the empathy the Navy doctors and nurses showed her.

Seven years passed before Wald could talk about the ordeal with anyone other than the thousands of women, she found in a private Facebook group who had undergone similar tragedies. Now the mother of two, Wald said her trauma had broadened her support for abortion rights. "It definitely made me more empathetic to the whole spectrum of why women get abortions," she said. "Now I'm loud and proud. It's not about me. It's about my daughter."

Federal judges ruled in separate cases in 2002 that the military was required to pay for the abortion of anencephalic fetuses, according to a 2013 Congressional Research Service report. Both rulings were reversed on appeal. According to the ruling of one of those appellate courts, the Supreme Court had decided in a 5-4 ruling that the right to abortion does not include "a constitutional entitlement to the financial resources" necessary to exercise that right. Continuing such high-risk pregnancies can endanger a woman's health even more than an uncomplicated pregnancy in the U.S., which has a far higher maternal mortality rate than other high-income nations, according to the Centers for Disease Control and Prevention. Carrying a dying fetus to term is potentially lethal and can also severely harm a woman's mental health, doctors say.

Five states with abortion bans — South Carolina, Louisiana, Utah, Mississippi, and Georgia — allow some exceptions for severe fetal defects, according to the Guttmacher Institute, a research group that supports abortion rights.

Only two abortion-banning states, Utah, and South Carolina, make exceptions for rape or incest, cases in which the military has vowed to provide access.
