
A professed wise man named Solomon penned the following, "To every thing there is a season, and a time to

Director Echelon 24 Virginia American Legion

VA Echelon 24 has been revitalized. This past year an effort to renew membership and recruit new members has been successful. We are currently at 100% of last years goal.

At the conference and convention meetings our discussions centered on how we can best serve women veterans and how to reach them.

Echelon 24 is working with Women's Outreach of Virginia American Legion on several projects. We held a Women Veterans Conference & Forum. Presentations were made explaining benefits available and guest speakers were from VAMC. The forum allowed women to express any concerns they had and to provide contacts.

At the Women's Memorial 2023 during the Jessica Lynch presentation we donated hygiene products, clothing, and quilts to Department of Veteran Services Project.

Echelon 24 also joined in with other organizations to support an Army Reserve Unit of MP's deployed overseas. While the whole unit is receiving care packets, the 33 women MP's are receiving feminine related packages provided by Echelon 24 and Women's Outreach members.

On July 29th 2023 we are combined with the Women's Outreach and presented the 2nd Annual Women Veterans conference in Virginia. We also invited Department of Veterans Services, DAV and VFW to participate. Representatives from VA Hospitals in Virginia attended. Topics include PTSD, MST, Homelessness, Burial Benefits, and how to file a claim. Several of our 20 & 4 members are Accredited Service Officers.

We are currently planning for our next conference on May 4th in Fairfax, VA.

BE THE ONE TO HELP END WOMEN VETERAN HOMELESSNESS

It is an established fact that women veterans are at a greater risk of homelessness than men. Women who have served in the United States military are three to four more times likely to become homeless than non-veteran women. The challenges they face when returning to civilian life, including raising children as a single parent, dealing with psychological after-effects of events such as military or sexual trauma, or the continued existence of employment and housing barriers are tall contributing factors toward women veteran homelessness.

Despite the VA having built the largest integrated network of homeless assistance programs in the country serving more than 199,000 homeless women veterans in FY 2022, homelessness among female veterans has increased on average 2% per year, while homelessness among male veterans declined by 3% during the same period.

So how can you, and your Echelon help homeless Echelon 24 also joined in with other organizations to support an Army Reserve Unit of MP's deployed overseas. While the whole unit is receiving care

So how can you, and your Echelon help homeless female veterans in your community? There are several ways you can Be the One for those female veterans who need your help and support.

- SUPPORT VA PROGRAMS. The VA has several programs aimed at ending homelessness among women veterans. You or your Echelon can support these programs by volunteering your time or donating your resources.
- RAISE AWARENESS. Improve awareness of the issue and dispel myths related to it. This could involve organizing community events (even in partnership with your American Legion Post), sharing information on social media, or advocating for polity changes.
- 3. PROVIDE EMPLOYMENT OPPORTUNITIES. If you are a business owner, consider hiring veterans. The Homeless Veterans Community Employment Services (HVCES) helps to improve employment outcomes for homeless veterans, including women veterans.

- 4. OFFER HOUSING. If you have rental properties, consider participating in the US Department of Housing and Urban Development and VA Supportive Housing Program (HUD-VASH) which provides subsidized permanent housing with VA-supported case management.
- 5. DONATE TO NON-PROFITS. Identify the nonprofit organizations that provide services to the homeless veterans (particularly women veterans- because there aren't very many). Your donations of time and resources can also help these organizations provide essential services.
- 6. ADVOCATE FOR POLICY CHANGE. Advocate for broadening definitions of "veteran" and "homeless "thereby increasing eligibility for care and benefits. Currently, most available housing options for homeless women veterans fail to recognize the need to keep families intact, particularly those families with opposite-sex children.

Identify opportunities to Be the One for homeless women veterans by partnering with other Veteran Service Organizations, faith-based organizations, non-profits or other philanthropic organizations to collaborate and to provide resources to fill gaps that make women veterans vulnerable to homelessness.

Find ways to shift the focus of our approach in serving women veterans to direct efforts and resources on preventing the problem.

Currently the VA spends approximately \$136,000 in services for every homeless veteran, and yet all of it is spent after the veteran becomes homeless rather than to prevent transitioning female veterans from becoming homeless in the first place. There is a need for a paradigm shift to focus on physical and mental health issues that may have occurred during military service; ensuring transferable career skills and programs to assist women veterans to adjust their identities to a civilian culture.

Issues that you can support include lobbying for Congress to give the VA the authority to help meet

the health care and mental health needs of women veterans, but also their children through direct or coordinated care. Partner with community agencies to provide child support, especially for single mothers; as well as to monitor the long-term health and behavioral effects of parents' service-related trauma and/or homelessness.

Campaigns that your Echelon could consider include improving national awareness of the issues to include:

- 1. Develop state and local campaigns to dispel myths of homelessness.
- 2. Work with non-profits and the VA to find ways to better identify and treat female veterans who experience military sexual trauma. Often this manifest in the workplace with increased absenteeism or performance-related issues. Education of local employers.
- Work with community leaders to conduct need assessments to identify better housing practices and help target prevention/early interventions.
 Work with military installations and family support services to support transitioning service members.
- 4. Start a local campaign to assist women veterans in becoming more comfortable identifying as veterans so they can access needed benefits.

These recommendations are just examples of how each of you can Be the One for another female veteran and can make your individual effort toward ending women veteran homelessness.

Minutes from the 67th Bivouac

The 67th Annual Bivouac was held at the Charlotte, North Carolina Convention Center. Registration began at 0800 in Room 217 on Thursday August 24, 2023. A Logbook was on display and the Ways and Means Committee displayed items for the silent auction. National Aide presented a personal gavel to Director VIP. Committee meetings began around 08:10 and were recessed at 1200 for lunch. Meetings resumed at 1300 and were adjourned at 14:00.

At 14:17 Internal Affairs was called to order by the Judge Advocate (JA). The first item of interest was the need for bonding of the national disbursing director; secondly, FL-5 has not paid dues in at least three years. A letter was sent by the national aide and there was a telephone conversation last year to address this concern. A follow-up letter should be sent via priority mail notifying FL-5 that their charter will be revoked if they remain non-compliant. Lipinski, IL-8, stated that there should be an audit of their financial records; thirdly, everyone is encouraged to learn what the requirements are for the logbook display and participate in the program. There is a \$25.00 prize given to the winner of the logbook display: fourthly, the website needs updating. An ad hock committee should be formed for this purpose. Callaway, IL-8, suggested that Beverely Fitch of IL-8 be appointed as the new emblem sales NMI. She also stated that Fitch has vendors already set up; Davis, MA-2, suggested that the policy and procedure manual be digitized. The members of this ad hock committee will be Davis, Kimelton, Dayhoff, Cauthen, and Lepinski; Dayhoff, TX-31, suggested that information be electronic which would take pressure off the aide. She stated that she has two IT degrees and is skilled in website setup as well as social media. Additionally, she stated that the information would be secure. Rideaux, CA-1, stated that she would not give phone numbers or addresses of CA-1 members to national aide. Lepinski, IL-8, stated that we must go digital to bring in younger members; JA called for credential report. Registration NMI reported: National officers, six, PND, four, Cadre, seven, Delegates, ten, making total

number of attendees 27. The number of echelons registered was nine. Authorized votes are AL, three, AZ, nine, CA, seven, Fl, six, IL, five, MA, six, NC, zero, TX, three, and VA, five (authorized votes are based on paid votes and the presence of the cadre member for that echelon); JA asked for any further business to come before the floor. Hearing none JA proceeded to ask for the list of officer nominees. Then Rideaux, CA-1, wanted clarification as to why a donation letter with the EIN number that Jr. Vice Director requested from National aide did not have the EIN number. Nominating Committee NMI presented the list of officer nominees: Director VIP, Georgian Callaway, Senior Vice Director, Mildred Wright-Pearson, Junior Vice Director, Jan Lepinski, CQ Colleen Heck, Assistant CQ Sandra Davis, Sky Pilot, Millie Hampton and Tweila Cauthen, National Aide, Earnestine Doubek and Lisa Dayhoff, and Dispersing Director Judi Beischel. Judi Beischel AZ-35 announced that a cocktail reception by Director VIP Shannon will take place at the Home2 suites on the pool level at 5pm. Cauthen, AZ-35, announced that she signed up 101year-old Rowena Baggs of Ohio to American Legion Post 2, birthday August 27, 1919. Post 2 members organized a march to her house which included newspaper coverage, the mayor and Girl Scouts.

Internal affairs adjourned at 16:04

Friday August 25, 2023, the 67th annual Bivouac resumed at 0800, Charlotte, NC Convention Center in room 221A. Registration continued as well as the Ways and Means silent auction and the Logbook display. Memorial Service was conducted at 08:15 by the Sky Pilot. The meeting was opened by Director VIP Shannon at 08:40, colors being in place hands salute, the pledge of allegiance and the preamble to the 20 and 4 Constitution were recited. Roll call of officers and cadre members by national aide. All officers were present and accounted for. Tx-31 replaced their Cadre member with Dayhoff. Minutes of the Pre-Bivouac were called for. National Aide stated she needed a few minutes to get them together as they were not typed. Director VIP decided to proceed with the committee reports. Audit report was given by NMI Nehring, PND, attached. It was moved by Lepinski, seconded and

passed. The Bivouac report given by NMI Kimelton was not turned in. Moved by Schmidt, seconded and passed. Constitution and Bylaws report given by NMI Davis; no C & B changes recommended for this Bivouac. C&B should be posted on a website for transparency. Moved by Lepinski, seconded and passed.

Corporate report given by PND Schmidt; will get in touch with corporation in NC to find out our status. Moved by PND Barker, seconded and passed. Internal Affairs report given by PND Schmidt was not turned in. Moved by Heck, seconded and passed. Log Director report given by NMI Heck was not turned in. Moved by Callaway, seconded and passed. The Nomination committee report given by PND Jackson Kelley was not turned in. Moved by Lepinski, seconded and passed. Log Director report given by NMI Taylor; one logbook presented. I encourage all echelons to participate. Moved by PND Barker, seconded and passed. Question by Rideaux, CA-1: who sets membership goals? National Aide answered that the Director VIP sets membership goals for the year. Discussion on the topic rendered a motion by Lepinski that the Director VIP and Senior Vice Director set goals for the year by the closing of bivouac. Further discussion caused Lepinski to withdraw her motion. The National Jeep report given by NMI Rideaux was not turned in. Resolutions Report was given by PND Jackson Kelly, attached. Scholarship report given by PND Stanton; no report, scholarship application should be published in Oct. Jeep. Moved by PND Barker, seconded and passed. Service Report given by NMI Heck was not turned in. Moved by Senior Vice-Director Callaway, seconded and passed. Judge Advocate report given by PND Schmidt; did not receive any C&Bs for review. Moved by Davis, seconded and passed. The Disbursing Director report given by PND Beischel was not turned in, however, a lesser report was turned in and is attached. Moved by PND Barker, seconded and passed. The Ways and Means report given by Junior Vice Director Wright-Pearson was not turned in. Moved by PND Schmidt, seconded and passed. Echelon development report given by PND Barker; Lepinski will be starting an echelon in Michigan.

Moved by Davis, seconded and passed. The immediate PND report given by PND Barker was not turned in. Moved by PND Schmidt, seconded and passed. The National Director report given by Director VIP was not turned in. Moved by PND Barker, seconded and passed. Break for lunch, return at 13:15

Unfinished business: National aide to read minutes of the pre-bivouac. National aide began to read minutes, PND Barker moved that it was no point in reading the minutes now because the information had been given by others. Seconded and passed. Please send your concerns to ad hock committee. Final credential report by registration NMI: national officers, six, PNDs, four, cadre, ten, delegates, 16, alternate delegates three plus one guest. The number of attendees was 39. The number of registered echelons was ten. Total authorized votes are AK, one, AL, three, AZ, nine, CA, seven, FL, six, IL, five, MA, six, plus two alternates, NC, seven (paid at Bivouac), TX, four, VA, five plus one alternate. The total number of authorized votes is 53. Election of officers, two positions had opposition and all opposing candidates gave a two-to-three-minute speech. The elected candidate for sky pilot was Tweila Cauthen and the elected candidate for national aide was Lisa Dayhoff. National aide cast one unanimous vote for the unopposed candidates. National Director VIP Shannon presented a personal gavel to PND Barker and incoming National Director VIP Callaway.

Good of the order: Hortense Toliaferro said she had some top hat pins of Connie Jo Popham and will give them to members. Callaway suggested that they be brought to the next Bivouac and any money's received from them could go towards a scholarship in Connie Jo's name. Banquet NMI stated that the meal ordered, and a name plate will be on the table at the banquet. Elexzanderia Carr thanked everyone who sent flowers and cards for the loss of her mother. Dorannetta Porter thanked everyone and said hang in there, no one is perfect, looking forward to working with the group. Tweila called Rowena Baggs and all present sang happy birthday to her.

THE MEMORIAL SCHOLARSHIP OF THE NATIONAL TWENTY

(A memorial to all women who served in the Armed Forces in all wars) FACT SHEET

A. Applicant Eligibility:

- A child, grandchild, or great-grandchild of a member in good standing of the Twenty and four or of a
 deceased member of the Twenty and Four who was a member in good standing at the time of her
 death is eligible to apply for the scholarship.
- An applicant (under I. Above) must be not less than sixteen (16) nor more than twenty-five (25) years
 of age by September 1st of the calendar year in which application is made.
- A Twenty and Four member in good standing (any age) who is returning to the work force or changing
 work fields and requires additional education is eligible to apply for the scholarship.
- Application filed on or before May 1* with the Scholarship NMI, using a Twenty and Four Memorial Scholarship application form and including all required attachments.

B. Scholarship Selection Criteria:

- 1. Eligibility (A. above)
- 2. Need for assistance
- 3. Scholastic standing
- 4. School activities
- 5. Community Activities (Volunteer orotherwise)

C. Grant Requirements:

- 1. Recipient to provide evidence of acceptance for admission in school of choice.
- 2. Recipient to provide evidence of enrollment in school of choice.
- Failure to provide evidence of acceptance (C. J above) by <u>Angust 1st</u> will cause automatic forfeiture of the scholarship, and it will be offered to the runner-up.
- Failure to provide evidence of enrollment (C. 2. Above) prior to each scheduled payment will cause payment to be withheld.

Note: "school of choice" must be a school, college, university, or vocational institution beyond the high school level!

D. Grant Payments:

- 1. Each grant shall be for the next succeeding school year only, in an amount not to exceed\$1,000.
- Payment of the grant shall be made to the appropriate education institution in the name of the Memorial Scholarship recipient, for tuition purposes only, and in equal amounts at the beginning of each term or qualifying enrollment (i.e.: \$500 at the beginning of each semester).
