PURPOSE

<u>REPRESENTATION</u>

The Bivouac shall be composed of delegates from all Echelons. Each Echelon shall be entitled to five (5) delegates and five alternates, plus one additional delegate and alternate for each f ifty (50) paid members. All Echelons that are in good standing by July 15, 2024, will be entitled to representation at the Bivouac. Members of the National Cadre from each Echelon shall be delegates to the National Bivouac with the right of the vote. This vote shall be exercised with their respective Echelons.

Echelons (all) 5 delegates and 5 alternates 50 + members 1 additional delegate and alternate 76 thru 125 members 2 additional delegates and alternates

DELEGATES

Only paid-up members for the year 2024 are entitled to be a member of the Cadre, a Delegate or Alternate Delegate to the Bivouac. A member is paid up when \$13.00 per capita for the current year has been received by the National Aide 40 days (July 15, 2024) prior to the National Bivouac. No per capita will be accepted for Bivouac count after that date nor will any Jeepette be listed on the Bivouac registry or receive a Bivouac badge.

CREDENTIALS

Blank forms will be furnished to all Echelon Aides. The credentials form (Delegate/Alternate Registration Form) must be returned to the National Aide by August 7, 2024. Accompanying the Credential form shall be a check in payment as per this schedule: \$10.00 for the Echelon and \$5.00 for each Jeepette listed on the form. If a Jeepette is deemed to be filling more than one position, do not list her twice. She is to be listed ONLY IN THE HIGHEST POSITION. That is: Past National Director, Current National Officer, National Cadre Member, Echelon Delegate and finally, Alternate Delegate. ALL positions require \$5.00 for each Jeepette listed.

Delegate/Alternate Delegate badges will be issued at the Bivouac for all Jeepettes registered. In extenuating circumstances, registration corrections may be made by the National Aide and Echelon Officers must be present. The Echelon must have been registered and fees paid PRIOR to their arrival at Bivouac.



This year, our **Bivouac** will be held at the New Orleans Marriot Warehouse Arts District Hotel, 859 Convention Center Blvd, New Orleans, Louisiana on **August 22-23, 2024**. **You are responsible** for making **your own** hotel **arrangements**. The Department of Illinois American Legion has kindly set aside rooms for this year's Bivouac. If you choose to stay at this hotel, then complete the housing form provided herein. Please note that the **deadline** for making hotel reservations is **JULY 23, 2024**. Sleeping Room rate is \$185.76. The rooms are selling out quickly so make your reservation now.

It is almost time for our National Bivouac and I have a few reminders for everyone. Packets were sent out to the Echelons and should have

been received by now. I have heard from a few Echelons that they received theirs and from others that they have not. These packets include sheets of pre-printed and numbered Membership Cards (10 per page), one transmittal form per sheet of Membership Cards, a Bivouac report form, Bivouac money transmittal form, delegate form and officer certification form. I will have copies of these packets with me at National to provide to a representative of each Echelon that has not received their packet by then. If you need a copy before

Bivouac and are unable to locate one, please send me an email so that I can send you an electronic copy of the link to where you can find it on the National website. Remember that I am NOT able to process banquet ticket purchases, so please send those to the Bivouac NMI with your meal selections. Be aware that if your delegate form does not include a National Cadre member and I am not able to contact you about correcting that form, you will not have a registered representative at the Cadre Meetings. Please have all reports and Bivouac registration paperwork to me no later than 15 August so that I can finish preparations for registration.

A reminder about membership awards for next year, since we did have some who would have qualified were it not for the timing requirements. The following awards are currently included in the National Manual of Procedure:

- The Abbie Bachelder Trophy is awarded to the FIRST ECHELON to achieve 100% membership after October 1st or 30 days after Bivouac, whichever is later.
- The Barbara Mallow Award/Trophy is awarded to the first Echelon with a membership over 30 to achieve 100% membership by January 30th of the fiscal year.
- The Lillian Cleveland Award/Trophy is awarded to the Echelon with the most new Twenty and Four members by June 30th.

This has been an enlightening year for me. I have gained more mentors than I previously had, which can only help me grow as a Jeepette and a Legionnaire. There are a lot of plans in the works to help improve our paperwork processes moving forward that will be discussed at Bivouac. I truly appreciate everyone's faith in me and am looking forward to working with everyone in the future.

Echelons are encouraged to visit the hellogirls.org website and contact their congresspersons to support this award. AMERICA'S FIRST WOMEN SOLDIERS Frequently Asked Questions

Who were the "Hello Girls"? This term is a nickname for women who served as U.S. Army Signal Corps Telephone Operators during World War I (1917-1918). They were the first American women servicemembers who served in support of combat operations - our first women soldiers sent to fight.

What was their impact? In addition to helping win the war, these women paved the way for future generations of female service members. Furthermore, the service of women in World War I helped convince the nation that women deserved the right to vote, and directly led to the passage of the 19th Amendment granting them that right.

What exactly did they do? These women were sent overseas to run telephone switchboards in support of military operations (radios were still new, and other forms of

communication were slow and unreliable). They were often in direct contact with front-line troops, coordinating infantry attacks and artillery barrages.

Was their work dangerous? Yes! They regularly worked within enemy air raid and artillery range. On one occasion, a team continued to work while their building literally burned down around them. They were also exposed to disease – including the Flu Pandemic. Two women died while in service to their nation.

What happened to them after the war? The Army disbanded the female telephone operator units and the women returned to civilian life. Soon, they discovered that they were not eligible for veteran recognition and benefits from the government.

Why were these women not recognized as veterans? It is difficult to understand or explain. They were recruited into the Army Signal Corps, wore uniforms, took orders,

and directly supported combat operations. They were officially recognized by battlefield commanders, including Commanding General John. J. Pershing. Perhaps the best answer is that after the war, the country simply wanted to move on.

How did they achieve recognition? The operators and their supporters spent decades pursuing legal and legislative approaches, submitting over 50 different bills until Congress finally granted the women veteran status in 1977 - nearly six decades later.

Who is leading this Congressional Gold Medal effort? Descendants of the women, with the World War I Centennial Commission, women veterans, and volunteers! The American Legion and the VFW have also endorsed this effort.

How is a Congressional Gold Medal awarded? Two thirds (2/3) of both chambers must agree to cosponsor this type of legislation. We are close to this threshold in the Senate; we need your help to secure the votes in the House!

What other military groups have received the Congressional Gold Medal? For World War II, the Native American Code Talkers, Women Airforce Service Pilots, Chinese American veterans, 6888th Central Postal Directory Battalion and others have been recognized. For World War I, the 369th Harlem Hell fighters have been honored.

Why is it important to award the Medal now? In September 2024, the National World War I Memorial will be dedicated in Washington D.C., making this year a fitting occasion to honor the women who helped win that war. Also, since 2024 is an election year, if the current bill to award the Hello Girls the Medal does not pass, the effort will have to start all over again next year.
