#### Tweila-Rochelle Cauthen, Sky Pilot

"To everything turn, turn, turn...There is a season turn, turn, turn...And a time to every purpose

under Heaven. A time to be born, a time to die...A time to plant, a time to reap...A time to kill, a time to heal...A time to laugh, a time to weep," Turn! Turn! Turn! Song by The Byrds written by Peter Seeger.

For certain, words of truth taken from the Bible in the Book of Ecclesiastes, Chapter 3, however, apropos to all living persons. As your National Sky Pilot, I have been traveling and serving. On 4 September 2024, I represented the 20 and 4 at Arlington National Cemetery to honor U. S. Army Chaplain Lt George Fox. His resting place finally received its marker. He was one of the four chaplains we honor every February. The American Legion National Commander Jim LaCoursiere, American Legion Auxiliary National President Trish Ward, and the ALA Eastern Division President Lauren Lloyd were also attendees. The story of the heroism of the four chaplains and Coast Guardsman Walter David, Jr. exemplified courage that many would wince at such a given time.

At the age of 106 years old, Roena Bayes left Time and entered Eternity. She was a member of Echelon Arizona (AZ-35), and the oldest living member of our Order. Roena was the third female in The American Legion history to be



elected as a Department Commander. Her accomplishments are too numerous to list, however, Echelon AZ-35's Resolution touts her sacrifices and service, and was the only one read at her services. I had the privilege to serve as the burial watch guard as she was Lying in State, and served at her funeral as well. Doranetta Porter (AZ-35), also participated in the graveside guard and burial detail along with The American Legion Posts 137 Farmville, OH, 223 Hicksville, OH and VFW Post 5655 Sherwood, OH.

While celebrating Roena's life, others were spending time dealing with tragedies from Hurricane Helene. Upon return, we received the call that six of my relatives and three battle buddies were missing in Asheville, NC. With no time to waste, we rented and loaded up a 19 foot UHaul to the brim with water, blankets, non-perishables, sanitary products, baby diapers and other items and drove to the safe zone sites. Fortunately, all family members were finally located, as well as our battle buddies, however, about 230 have died in North Carolina, and bodies are still being recovered. October...a time to heal.

They're love and kindness, in every way!





#### News from The Big Sky and Beyond

Jeepette Carol Gruwell reports that Grace Haven, a transitional home for women veterans in Great Falls, is still being supported by our Great Falls Jeepettes. There are currently two women veterans with children living there and enrolled in their program as the facility is not yet complete.

**Past Director VIP Linda Cousineau** and **Jen Dalrymple** successfully facilitated the transfer of a female veteran on hospice to a facility much closer to her home. They followed that up with several days helping another female veteran stack firewood for the winter.

Eight Jeepettes were able to meet for Fall Bivouac on 26 October at Fort Harrison, outside Helena. Our new Director VIP Janice Dobb attended virtually due to illness. Much was accomplished: a new committee was created to revise our constitution and bylaws, a vacancy on our officer list was filled, and we voted to send \$250 to an identified Jeepette in need who was severely affected by the hurricanes and tornadoes in Florida. There were also door prizes for everyone in attendance. It was also revealed that our Senior Vice Director Kim Kay McCarty Martin is still running unopposed for Department Commander while two other of our members, Past Director VIP Linda Cousineau and Junior Vice Director Irene Dickerson are both part of a threeway race for Department Vice Commander! Exciting times!

On a completely different note, Jeepette Lisa Milner in Oklahoma locally coordinated a Korean War Veterans Appreciation Day on 2 November with JaeHo Yi from the South Korean American Association, In addition to organizing, publicity, going to the county commission and Senator Lankford's office, she also made almost 200 Jumeokbap (Korean flavored rice balls), Japchae (Korean noodles) and eight dozen Mayak Eggs (Korean crack" eggs) – no drugs involved! Of the 22 Korean War Veterans identified by Senator Lankford's office only 17 or their representatives were able to attend with family – coming from as far away as Michigan and South Padre Island, Texas. Members of the South Korean Consulate also participated. A slide show was shown of South Korea immediately after the war and how it is today. totally modern and rebuilt. The remaining medals will be hand-delivered to those who could not attend. The ceremony was also broadcast live on Facebook. Approximately 150 people attended. While two ceremonies were previously held at Guthrie Post 58, this ceremony was a first for Tulsa! Many thanks for the inspiration and a job well done, Lisa! #### **Approval of minutes**

• A motion was made by Past AZ Director Roberta "Bobbie" Kimelton to accept the minutes of the previous bivouac as they were presented in the National Jeep and seconded. The motion was approved.

#### Reports

- Officers Reports
  - Dispersing Director's Report was presented by PND Judy Beichel: The banquet expected tonight is going to be huge with over 125 people. Last year's cost was \$6,802, this year it is \$11,979.39. There is confusion about paperwork needed for reimbursement. Forms are available at the front table.
  - Audit Report was presented by National SVD Mildred Wright-Pearson: One discrepancy found in the checking account for check number 232 for \$78.57 written on 14 June 2024. No discrepancies found in the savings account.
  - Bivouac Report was presented by Roberta "Bobby" Kimelton: The Bivouac for 2024-25 is held at the New Orleans Marriott Warehouse Art District. The banquet is to be held on 8-23-24 with 127 paying reservations. Dress code is Great Gatsby themed or business dress. Meal choices include blackened fish, sage chicken breast, or vegetarian jambalaya. Ticket costs are \$75 per person.
  - Constitution and Bylaws Committee report was presented by Millie Hampton: No formal request for Constitution and Bylaws change received since the 2023 Bivouac. Several areas of concern needed clarification. Red lines will be sent out within 30 days of the convention, and a resolution for permanent change for the 2025 bivouac will be made.
  - Corporation report was presented by Past National Director Cheri Stanton: Pat Harris needs to change her name on the official document. The young lady from North Carolina will sign the corporation papers. Diane Schmidt has the necessary paperwork to finish up the corporation.
  - Internal Affairs report was presented by National Judge Advocate PND Diane Schmidt: Discussion on Echelon 5, a letter was sent to Director Eunice Butts. The cadre voted to reimburse Tweila Rochelle-Cauthen \$25 for an incident at the airport. Procedures of echelon amendments were explained. A letter will be sent to members of Echelon 5 explaining the dissolution and offering membership in Echelon 30.
  - Scholarship Report was presented by Past National Director Cheri Stanton: This year, Fort Henson and I met to look over our scholarship applications. We have two sisters that have applied for our \$500 scholarship. We haven't had anyone apply for a scholarship in many, many years. So we, Fort Henson and I, would like to recommend that both girls receive a \$500 scholarship check. One is for Olivia Marie Downs and the other is for Mary Ophelia Downs, and they qualify by their mother, Jeanne Downs, from Alabama.
  - Service Commission Report was presented by Colleen Heck: The Commission met on August 22, 2024, at 10:30 AM in Marriott Warehouse Arts District Hotel, New Orleans, Louisiana. It consisted of Colleen Heck, Tweila Rochelle-Cauthen, Jennifer Kushner, Dornetta Porter, Rita Chandler, and Tonya Muneer. They discussed various activities and services provided by Virginia and Arizona echelons, including mentoring, community service, and support for women veterans.
  - Judge Advocate Report was presented by Diane Schmidt: The National sent a letter to Eunice Butts, Director of Echelon 5, to dissolve Echelon 5 since it was out of compliance, asking them to come into compliance since no membership dues have been paid in five years. The Judge Advocate participated in a Zoom meeting to encourage Echelon 5 to update their constitution and bylaws. The Judge Advocate also reviewed and approved the constitutional bylaws from the Echelons of Virginia, Alabama, and Illinois.
  - Budget report was presented by PND Judy Beischel: The budget committee met on August 22, 2024. A recommendation was made to create a marketing committee with a \$1,000 budget. The budget was reviewed with no other adjustments. The dues were increased from \$13 to \$15 per capita to balance the budget at \$12,225 per capita.

- Finance report was presented by PND Judy Beischel: The beginning checkbook balance on August 1st was \$12,015.86, and the ending balance on July 31st was \$17,043.30, an increase of \$5,027.44. The savings account balance increased from \$57,517.29 to \$59,535.83, an increase of \$2,018.54 due to interest.
- Others Reports
  - Report on Illinois sales was presented by Beverly Fitch: Emblem sales netted over \$903 in the last day and a half.
  - National Jeep Report was presented by Managing Jeep Editor PND Diane Schmidt. The report discussed the development of an all-inclusive Jeep, the issues with timely submissions, and the positive feedback received. They also mentioned the need for tweaks and the importance of teamwork.
  - Echelon Development Report was presented by PND Cheri Stanton: The Central Division, working with people from Indiana, is trying to start an echelon. The Eastern Division, represented by Josephina Delaney Alterses of New Jersey, is working with Millie to start an echelon in New Jersey. Efforts are also being made to start echelons in Michigan and Colorado.
  - SkyPilot Report was presented by the Sky Polit Tweila Rochelle-Cauthen: Four deaths within the ranks were reported this past year. Condolences were sent to the families with appropriate messages and tokens. Six cards and tokens were sent to family members of ailing members. The Sky Pilot worked tirelessly to ensure that everything was sent appropriately and followed up on any issues with addresses.
  - Credential report was presented by Linda Cousineau: The final credential report showed an additional member from North Carolina, making the total membership present 37.
  - The membership report was presented by National Aide Lisa Dayhoff: Updates on membership numbers were given, including Alaska at 75% and Wisconsin needing to increase their membership to meet the minimum requirement of 10 members.

#### **New Business**

1. Creation of a Marketing Committee for the National 20/4 proposed by Echelons 8 (Illinois), 25 (Arizona) and 31 (Texas): The proposal includes the establishment of a marketing committee to promote the organization and attract grants and outside donations through the creation of a 501(c)3 corporation.

- 2. Final Motion: A vote be taken at our business meeting at bivouac on August 23, 2024 in New Orleans, Louisiana, to establish a National 20/4 marketing committee, and that the executive committee is charged with appointing a qualified and appropriate five-person committee to serve the following rotating terms of two three-year terms, two two-year terms, and one one-year term for the intended purpose as stated in this resolution, and be it further resolved that the internal affairs committee authorize the creation of a 501(c)3 corporation under the direction of the National 20/4 as the corporate entity of the United States responsible for receiving the receipts of outside grants and fund raising.

A. Discussion: The need for a marketing committee to promote the organization and attract grants was discussed. Concerns were raised about mixing the 501(c)3 with the committee, and the importance of adhering to IRS regulations was highlighted. The necessity of taking the organization to the next level with substantial funding was emphasized.

3. Final Motion By recommendation of the Budget Committee of the National 20/4, that at the business meeting of the National 20 and 4 be held in New Orleans, Louisiana on August 23, 2024, that a vote be taken to increase the per capita membership dues from \$13 to \$15, effective July 1, 2025, for the 25-26 membership year.

A. Original Motion By recommendation of the Budget Committee of the National 20/4, that at the business meeting of the National 20/4 to be held in New Orleans, Louisiana on August 23, that a vote be taken to

increase the per capita membership dues from \$13 to \$15 affective September 1, 2024.

- B. Discussion:
  - 1) Discussion on the effective date of the dues increase and the need for local echelons to have time to adjust their dues accordingly.
  - 2) Clarification that the increase will start in 2025, giving echelons a year to figure out how they want to adjust.
- C. Voting Results: All in favor say aye. Aye. Any opposed? Opposed. The ayes have it.
- 4. Final Motion: We have a motion to accept the two scholarships for \$500 each for Olivia Marie Downs and Mary Ophelia Downs.
  - A. Discussion included questions about the usual number of scholarships given, the amount of money available, and the fact that there haven't been any applications in years.
  - B. Past National Director VIP Diane Schmidt seconded the motion.
  - C. Voting Results: Motion passed.
- 5. Final Motion: The budget committee recommended creating a marketing committee with a \$1,000 budget and increasing the dues from \$13 to \$15 per capita to balance the budget at \$12,225 per capita.
- 6. Final Motion Vote for National Senior Vice Director.
  - A. Results: By a majority of votes, Colleen Heck is the Senior Vice Director.
- 7. Final Motion Past National Director Diane Schmidt made a motion that the ballots be destroyed. Past National Director Carol Barker seconded it. The motion passed.
- 8. Final Motion: A motion was made that one ballot be cast for all uncontested positions.
  - A. The motion was seconded by Past National Director Carol Barker.
    - B. Results: All in favor? Aye. Any opposed? The motion passed.
